**SECTION 4: First aid measures**

**Description of first aid measures**

**After inhalation:**

Loosen clothing as necessary and position individual in a comfortable position. Seek medical advice if discomfort or irritation persists. If breathing difficult, give oxygen. Remove to fresh air. Give artificial respiration if necessary.

**SECTION 5: Firefighting measures**

**Extinguishing media**

**Suitable extinguishing agents:**

If in laboratory setting, follow laboratory fire suppression procedures. Use appropriate fire suppression agents for adjacent combustible materials or sources of ignition. Use water spray, dry chemical, alcohol-resistant foam, or carbon dioxide.

**Unsuitable extinguishing agents:** None

**Special hazards arising from the substance or mixture:**

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Keep product and empty container away from heat and sources of ignition. Not considered to be a fire or explosion hazard.

**Personal precautions, protective equipment and emergency procedures:**

Wear protective equipment. Transfer to a disposal or recovery container. Avoid contact with skin and eyes, and clothing. Use spark-proof tools and explosion-proof equipment. Use respiratory protective device against the effects of fumes/dust/aerosol. Keep unprotected persons away. Ensure adequate ventilation. Keep away from ignition sources. Protect from heat. Stop the spill, if possible. Contain spilled material by diking or using inert absorbent.

**Environmental precautions:**

**Methods and material for containment and cleaning up:**

If in a laboratory setting, follow Chemical Hygiene Plan procedures. Collect liquids using vacuum or by use of absorbents. Place into properly labeled containers for recovery or disposal. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. **SECTION 7: Handling and storage**

**Precautions for safe handling:**

Minimize dust generation and accumulation. Wash hands after handling. Avoid dispersal of dust in the air. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid generation of dust or fine particulate. Avoid contact with eyes, skin, and clothing.

**Conditions for safe storage, including any incompatibilities:**

Store in a cool location. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Store in cool, dry conditions in well sealed containers. Keep container tightly closed. Protect from freezing and physical damage.

**Appropriate engineering controls:**

Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
