**SECTION 4: First aid measures**

**Description of first aid measures**

**After inhalation:**

Move exposed individual to fresh air. Loosen clothing as necessary and position individual in a comfortable position. Seek medical advice if discomfort or irritation persists. If breathing difficult, give oxygen. If not breathing, give artificial respiration. Do NOT use mouth-to-mouth resuscitation.

**After skin contact:**

Wash affected area with soap and water. Rinse/flush exposed skin gently using water for 15-20 minutes. Seek medical advice if discomfort or irritation persists. Remove contaminated clothing and wash before reuse.

**After eye contact:**

Protect unexposed eye. Rinse/flush exposed eye(s) gently using water for 15-20 minutes. Remove contact lens(es) if able to do so during rinsing. Seek medical aid.

**Advice for firefighters:**

**Protective equipment:**

Use NIOSH-approved respiratory protection/breathing apparatus.

**Additional information (precautions):**

Move product containers away from fire or keep cool with water spray as a protective measure, where feasible. Use spark-proof tools and explosion-proof equipment.

**SECTION 6: Accidental release measures**

**Personal precautions, protective equipment and emergency procedures:**

Wear protective equipment. Transfer to a disposal or recovery container. Avoid contact with eyes, skin, and clothing. Use spark-proof tools and explosion-proof equipment. Use respiratory protective device against the effects of fumes/dust/aerosol. Keep unprotected persons away. Ensure adequate ventilation. Keep away from ignition sources. Protect from heat. Stop the spill, if possible. Contain spilled material by diking or using inert absorbent.

**Environmental precautions:**

Prevent from reaching drains, sewer or waterway. Collect contaminated soil for characterization per Section 13.

**Methods and material for containment and cleaning up:**

If in a laboratory setting, follow Chemical Hygiene Plan procedures. Place into properly labeled containers for recovery or disposal. If necessary, use trained response staff/contractor. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air. Collect solids in powder form using vacuum with HEPA filter.

**SECTION 7: Handling and storage**

**Precautions for safe handling:**

Wash hands after handling. Avoid dispersal of dust in the air. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid generation of dust or fine particulate. Avoid contact with eyes, skin, and clothing.

**Conditions for safe storage, including any incompatibilities:**

Store in a cool location. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Keep container tightly closed. Store with like hazards. Store in a cool, dry well-ventilated area away from incompatible substances.

**Appropriate engineering controls:** Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
