**2. COMPOSITION/INFORMATION ON INGREDIENTS**

Highly refined mineral oils and additives.

The highly refined mineral oil contains <3% (w/w) DMSO-extract, according to IP346.

**3. HAZARDS IDENTIFICATION**

<b>Emergency Overview</b>	
<b>Appearance and Odour</b>	: Amber. Liquid at room temperature. Slight hydrocarbon.
<b>Health Hazards</b>	: Not classified as dangerous for supply or conveyance.
<b>Safety Hazards</b>	: Not classified as flammable but will burn.
<b>Environmental Hazards</b>	: Not classified as dangerous for the environment.

<b>Health Hazards</b>	: Not expected to be a health hazard when used under normal conditions.
<b>Health Hazards Inhalation</b>	: Under normal conditions of use, this is not expected to be a primary route of exposure.
<b>Skin Contact</b>	: Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis.

**4. FIRST AID MEASURES**

Clear fire area of all non-emergency personnel.

**Specific Hazards** : Hazardous combustion products may include: A complex mixture of airborne solid and liquid particulates and gases (smoke). Carbon monoxide. Unidentified organic and inorganic compounds.

**Suitable Extinguishing Media** : Foam, water spray or fog. Dry chemical powder, carbon dioxide, sand or earth may be used for small fires only.

**Unsuitable Extinguishing Media** : Do not use water in a jet.

other containment material. Reclaim liquid directly or in an absorbent. Soak up residue with an absorbent such as clay, sand or other suitable material and dispose of properly.

**Additional Advice** : Local authorities should be advised if significant spillages cannot be contained.

**7. HANDLING AND STORAGE**

**General Precautions** : Use local exhaust ventilation if there is risk of inhalation of vapours, mists or aerosols. Properly dispose of any contaminated rags or cleaning materials in order to prevent fires. Use the information in this data sheet as input to a risk assessment of local circumstances to help determine appropriate controls for safe handling, storage and disposal of this material.

**Handling** : Avoid prolonged or repeated contact with skin. Avoid inhaling vapour and/or mists. When handling product in drums, safety footwear should be worn and proper handling equipment should be used.

**Storage** : Keep container tightly closed and in a cool, well-ventilated place. Use properly labelled and closeable containers. Storage Temperature: -20 - 50 °C / -4 - 122 °F

**Unsuitable Materials** : PVC.

**Additional Information** : Polyethylene containers should not be exposed to high temperatures because of possible risk of distortion.

**Additional Information** : Shell has adopted as Interim Standards the OSHA Z1A values that were established in 1989 and later rescinded.

**12. ECOLOGICAL INFORMATION**

Ecotoxicological data have not been determined specifically for this product. Information given is based on a knowledge of the components and the ecotoxicology of similar products.

- Acute Toxicity** : Poorly soluble mixture. May cause physical fouling of aquatic organisms. Expected to be practically non toxic: LL/EL/IL50 > 100 mg/l (to aquatic organisms) (LL/EL50 expressed as the nominal amount of product required to prepare aqueous test extract). Mineral oil is not expected to cause any chronic effects to aquatic organisms at concentrations less than 1 mg/l.
- Mobility** : Liquid under most environmental conditions. Floats on water. If it enters soil, it will adsorb to soil particles and will not be mobile.
