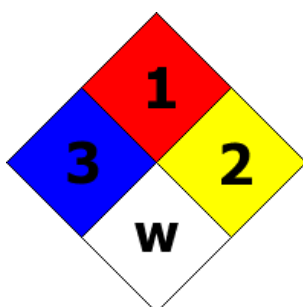

Description of first aid measures

After inhalation:

Loosen clothing as necessary and position individual in a comfortable position. Move exposed to fresh air. Give artificial respiration if necessary. If breathing is difficult give oxygen. Get medical assistance if cough or other symptoms appear.

After skin contact:

Rinse/flush exposed skin gently using soap and water for 15-20 minutes. Seek medical advice if discomfort or irritation persists.

SECTION 5: Firefighting measures

Extinguishing media

Suitable extinguishing agents:

Do NOT get water inside containers. Contact professional fire-fighters immediately. Cool containers with flooding quantities of water until well after fire is out. DO NOT USE WATER OR FOAM. For small fires, use dry chemical, soda ash, lime or sand. For large fires, use dry sand, dry chemical, soda ash or lime or withdraw from area and let fire burn.

Unsuitable extinguishing agents:

Special hazards arising from the substance or mixture:

Thermal decomposition can lead to release of irritating gases and vapors. Water Reactive; material will react with water and may release a flammable and/or toxic gas. This chemical poses an explosion hazard - reacts with water to form explosive hydrogen gas. May ignite or explode on contact with steam or moist air; may re-ignite after fire is extinguished.

Advice for firefighters:

Protective equipment:

Use NIOSH-approved respiratory protection/breathing apparatus.

Additional information (precautions):

Move product containers away from fire or keep cool with water spray as a protective measure, where feasible. Use spark-proof tools and explosion-proof equipment. Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Avoid inhaling gases, fumes, dust, mist, vapor, and aerosols. Avoid contact with skin, eyes, and clothing. Reacts violently and/or explosively with water, steam or moisture. Air sensitive.

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures:

Wear protective equipment. Use spark-proof tools and explosion-proof equipment. Ensure that air-handling systems are operational. Ensure adequate ventilation.

Environmental precautions:

Prevent from reaching drains, sewer or waterway. Collect contaminated soil for characterization per Section 13. Should not be released into environment.

Methods and material for containment and cleaning up:

Keep in suitable closed containers for disposal. Wear protective eyewear, gloves, and clothing. Refer to Section 8. Always obey local regulations. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.

Appropriate Engineering controls:

Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
